CONDITIONAL USE PERMITS

<u>CU-2019-0008</u>, <u>ALPINE SHOPPES</u>, <u>LLC</u>. Requests a conditional use permit to allow for the operation of a tattoo establishment located at 12592 Warwick Boulevard.
